An authorization deduct regular dueshall remain valid until written notice of cancellation is provide to Oregon Tech by the Association or until the employee is no longer a bargaining unit member, whichever occurs Tiostancel an authorization to deduct regular dues and onger have Oregon Tech deduct dues on a monthly basis, a bargaining unit member must give notice of cancellation to the Association. A bargaining unit member notice of cancellation received by Oregon Tech shall be forwarded to the Sociation. Cancellations are only effective after the Association has infeed Oregon Tech in writing that it has approved the cancellation or Oregon Tech has had topportunity to process the cancellation.

The Association shall promptly forward the Employer notice of cancellations of a dues deduction authorizatio All applications for Association membership or dues cancellation shall be submitted by employee to the Association.
